

### 2019 ANNUAL REPORT











In 2019, we launched our new curriculm for YourLife Finance Classes, a six-class series developed with our clients in mind. The classes in our new curriculum are focused on the basics of budgeting on a limited income, credit repair and recovery, how to prioritize bill paying and how to set future financial goals no matter your income. Each class in the series builds on the knowledge gained in the previous class, and clients leave each class with a homework assignment that will help them implement the concepts learned in class into their daily lives right away. By the end of the six class progression, our clients not only have the knowledge they need to understand their finances, but also have actual concrete strategies that they can use to change their lives today.

One of the most important indicators we track with our class participants is the number of classes they attend in our 6-class series. We know dosage is important when teaching financial education, but we also believe this is a good indicator to measure the quality of our volunteers and the materials we teach. During 2019, clients attending 2+ classes increased to 51%, up from 39% in 2018. Class participants are attending more classes in the series which allows us to measure outcomes over time. In addition to the increased class participation, we have also seen an increase in actionable outcomes such as opening a bank account and an improvement in their financial capability score which is a great indicator for change in attitudes and confidence over time.

In 2019, we graduated two groups of RISE! Seniors from Yes Prep Northbrook and Yes Prep Gulfton high schools. Of the 30 graduating girls, every one of them has been admitted to college and they can boast 116 college acceptance letters between them. Every RISE! graduate has applied for FASFA or other forms of financial aid, and together the girls have over \$45,000 saved for their future education. ## 2019 **IMPACT**

In 2019, we provided **423 CLASSES** teaching **4,303 INDIVIDUALS**. Those classes were taught throughout the city at **36 DIFFERENT COMMUNITY PARTNERS**.

During the 2019/2020 school year, we provided **2,835 HOURS OF GUIDANCE AND MENTORING TO 350 GIRLS**.
Majority of the girls served by our program come from a low to moderate income family.

The girls formed **14 GROUPS** and attended **8 DIFFERENT SCHOOLS**.




